- If the applicant is a company/cooperative society/foreign company/partnership/government organization, an authorized person shall sign the form.
- If the applicant is a government entity or a company, only forms stamped with the seal will be accepted.
- If the applicant is a company registered for more than 15 days, only forms stamped with the company seal will be accepted.
- A copy of the permit issued by Male' City Council for the premise must be submitted with this application.
- The original certificate of the previous permit should be submitted.
- Revenue Stamp of MRf 10 is required for this permit.
- A payment slip will be issued to the applicant once the application is processed. Payment must be made on the same day the payment slip is issued. Failure to make payment as above, would result in cancellation of the payment slip and application.
- Payments made by cheque shall only be accepted with a bank guarantee.

More Information:

- If the applicant is a company, cooperative society or a partnership, must submit the fee payment receipt with this application.
- If the applicant is registered at any government entity, the applicant must submit a copy of the registry.
- If a shareholder of a company is a foreigner or a foreign entity, import permit shall be issued to the applicant when the applicant has been registered as a foreign business under (Law No 4/79), The Law Governing Foreign Businesses.
- If there exist a permit to an establishment for which the applicant is seeking permission, the new permit will be issued upon cancellation of the previous permit. New permits to such an establishment will be granted if a letter from the owner of the establishment is submitted with the application stating that the previous permit holder has vacated the establishment and that all merchandise has been removed, and the establishment has been handed over to the owner, or a letter signed by the permit holder stating that he has ceased operations at the establishment is submitted. In case of companies, a board resolution to that effect would suffice.
- If the establishment owner is deceased, the right holders to the
 establishment shall sign the application form stating their no
 objection to granting a permit to the establishment. If the right
 holders are determined in a court of law, all right holders to the
 establishment must sign the application. It is a requirement to
 submit the copy of the court judgement on the right holders.
- If the application is for a permit on a vessel, a copy of the vessel registry must accompany the application.
- Application to sell imported goods as submitted to ascertain
 that the website is registered to sell imported items, a valid
 document has to be submitted to indicate the domain name
 registration, the domain name must be registered in the name of
 the applicant.
- If an application is submitted to operate a bar at a resort or a
 vessel, the application must be accompanied with the operating
 license issued by the Ministry of Tourism, Arts and Culture to
 operate tourist establishments.
